

Information ~ RE: Non-Corporeals.

We understand the phrase, “under the influence” to mean that in such a condition, one is not always acting in their best interests. Their judgment is impaired or clouded, etc. To an observer, it seems, “That’s not like ____.” – meaning their behavior is dramatically different from the norm.

In the case of an attachment, the person to whom the energy is attached may be inclined to behave in ways that seem foreign to them. For example – in the case of a discarnate that was alcoholic prior to passing, if they attach to Person X, we may notice: They didn’t used to drink, but lately they’re always tipsy. Another fact is the remarkable percentage of Suicides brought about due to an attachment’s influence..

In other words – people “aren’t themselves” or exhibit irrational behavior – when under the influence of a discarnate or dark force energy - because they seem to be thinking thoughts or ‘hearing things’ they don’t understand are not of their own making.

The remedy for this is a simple educational process, as the non-corporeal has been misinformed about its status and simply doesn’t understand that there IS a remedy available. Getting the attention of the discarnate or other non-human entity can be a very taxing experience – especially for the novice. There are a few very important concepts that would serve one who wishes to begin a course of study to learn *how to accomplish this.

- 1) Discarnates have learned NOTHING since they left the body.
- 2) They are often confused about their status and can be fearful and/or angry. These emotions are not conducive to the re-education that is required to enable them to participate in their recovery.
- 3) If they have “made a deal” with the dark side, they earnestly and honestly believe they are forever trapped – and may well have a DFE embedded within them. So,
- 4) One is well advised to be prepared for ANY eventuality prior to embarking on such an adventure.

IN our practice, we use a TRAINED Deep Trance Medium (in a hypnotic state) to act as a 'channel' through which the energy may speak, thus enabling communication with the individual acting as the director of the experience. The director (or Negotiator/Educator) must maintain conscious control of the situation, since – especially in the case of a DFE – it is possible for the energy to cause physical damage to one not “in control” of the situation. Thus we never attempt this work without a minimum of two trained professionals present.

The director (negotiator/educator) makes contact with the non-corporeal and establishes some rapport, and then proceeds – by asking questions and explaining what is possible (in some cases demonstrating to the energy what is possible, often with Angelic assistance) – to convince the energy of the reality that we do, in fact, have their best interests at heart. (In some cases they have been told repeatedly that they are Not to talk to us – so we must explain how that works as well.)

And then a director proceeds to use *established protocols to provide the energy verification of our intentions and explain to them the relief that is available. Once this is understood, in the overwhelming majority of cases, the entities recognize their error(s) and agree to disengage from the host and remove their adverse influences.

Most often, the discarnate has a relative or loved one who has gone into The Light and is available to confirm to the discarnate(s) the director's veracity, and we ask their help (again, using safeguards to avoid deception) and the process becomes one where trust is established so progress can be made.

When sufficient verification has taken place to the satisfaction of all concerned (a Spirit Guide is working alongside the Director and Medium), and any and all harmful influences have been removed, the individual who has come from the Light takes the discarnate(s) back with them into The Light.

Often the next step is angelic and intended healing, accomplished by sending light into the injured areas.
